Arizona Academy of Beauty, Inc. (OPE ID: 008864-00) received education stabilization funds Under Section 314(a)(4) of the Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA), Public Law No: 116-260, signed into law on December 27, 2020. This Fund Report applies to the student portion received under the Higher Education Emergency Relief Fund that is designated exclusively for emergency financial aid grants to students.

The Academy appreciates that Congress and the President have made these critical funds available for eligible students who have expenses related to the disruption of campus operations due to the coronavirus pandemic. We take receipt of these federal funds seriously and are distributing them in accordance with the CRRSAA-HEERF II and implementing guidance.

1. The institution signed and returned to the Department the Certification and Agreement [for] Emergency Financial Aid Grants to Students. The institution has used, or intends to use, 100 percent of the funds received under Section 314(a)(4) of CRRSAA-HEERF II to provide emergency financial aid grants to students.

2. The total amount of funds that the institution has received from the Department pursuant to the Academy's Certification and Agreement [for] Emergency Financial Aid Grants to Students is \$61716.00. These funds have not yet been received by the Academy. The Academy has decided to decline these funds due to administrative burden in managing these funds.

3. The total amount of emergency financial aid grants distributed to students under Section 314(a)(4) of the CRRSAA-HEERF II as of the date of this Fund Report is \$0. We will be distributing the emergency financial aid grants upon receipt of the funds.

4. The estimated total number of students at the institution eligible to receive emergency financial aid grants under Section 314(a)(4) of CRRSAA-HEERF II, as of the date of this Fund Report is approximately 30-45 students.

5. The total number of students who have received an emergency financial aid grant under Section 314(a)(4) of CRRSAA-HEERF II as of the date of this Fund Report is 0. We will be disbursing the emergency financial aid grants upon receipt of the funds.

6. The methods used by the institution to determine which students receive emergency financial aid grants and how much they would receive under Section 314(a)(4) of the CRRSAA-HEERF II will be provided upon further review of the Department of Education's guidance and interpretation of the law.
